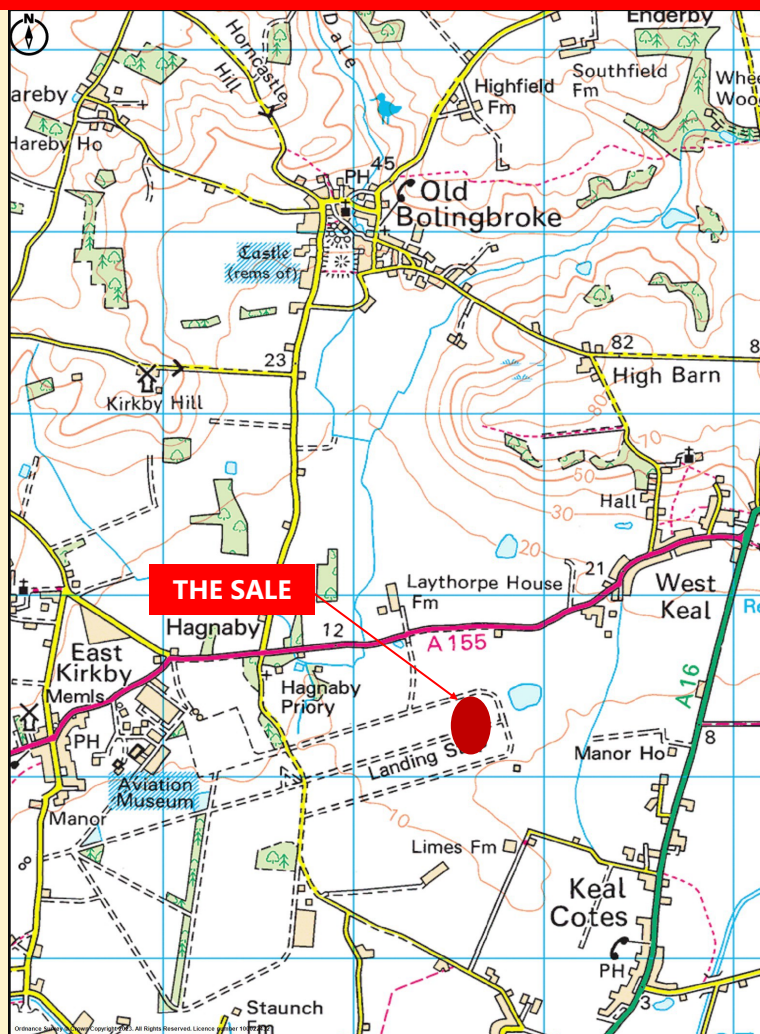
CONDITIONS OF SALE
